Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • Dieterich Bank has no affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Dieterich Bank does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Our joint marketing partners include an investment services company, a credit card services company, and insurance services companies.
